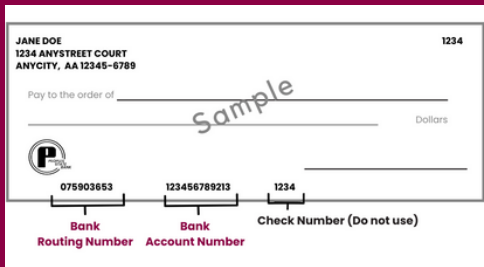
It's Tax Refund Season

To ensure your refund posts correctly to your Peoples State Bank account, here are a few tips:

Provide your correct Routing Number and Account Number to the IRS.

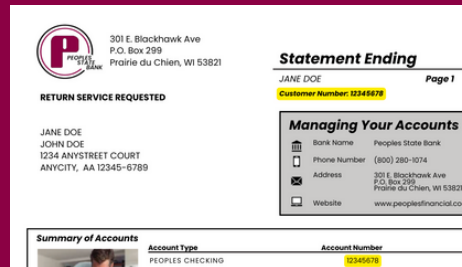
If you use a tax preparer, make sure they have the most current account information. If inaccurate information is provided, the refund will be returned to the IRS. In turn, the IRS will issue a paper check to the address listed on the tax return and can take 4-6 weeks to be received.

- Your Account number can be found on your checks/deposit slip or on your statement:

- Your account number is noted on your statement in the middle of the first page, which can be viewed through Online Banking or the OLB App.
 - Sample Statement:



Provide your tax preparer with the account type (checking or savings). Refunds will be returned if the transaction is coded incorrectly.

The IRS determines the effective date for the Tax Refund to be deposited. We post all ACH transactions on the effective date that is provided with the ACH record.
