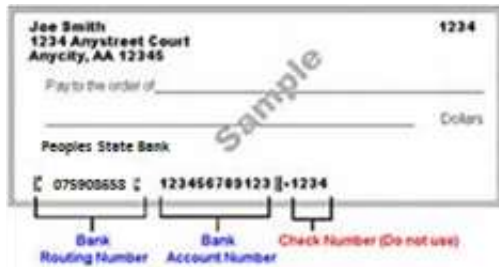


# It's Tax Refund Season

To ensure your refund posts correctly to your Peoples State Bank account, here are a few tips:

**Provide your correct Routing Number and Account Number to the IRS.** If you use a tax preparer, make sure they have the most current account information. If inaccurate information is provided, the refund will be returned to the IRS. In turn, the IRS will issue a paper check to the address listed on the tax return and can take 4-6 weeks to be received.

- Your Account number can be found on your checks/deposit slip or within Online Banking:

- “Welcome to Your Name”
- “All Services & Settings”
- “Modify Account Access”

**The name(s) on the refund must match the name(s) on the account.** Refunds will be returned if the person named on the refund record is not on the account.

**The IRS determines the effective date for the Tax Refund to be deposited.** We post all ACH transactions on the effective date that is provided with the ACH record.
